



## STADIUM REGULATIONS

Sports Complex of Futebol Clube de Alverca

The Stadium Regulations set out the basic rules to be observed by users (Members, other Spectators, Vendors, and Staff on duty) regarding the conditions of access to and stay in the Sports Venue.

### 1. DEFINITIONS:

For the purposes of these Regulations, the following shall mean:

1. **"Sports venue steward"**: a private security guard specifically trained to ensure the safety and comfort of spectators in sports venues and security rings.
2. **"Ban from sports venues"**: the temporary prohibition on holding official sports events at the sports venue in the same sport, age group, and categories in which the offences occurred.
3. **"Holding sports events behind closed doors"**: the obligation for the event organiser to hold official sports events at the sports venue under their management in the same sport, age group, and categories in which the offences occurred, without the presence of the public.
4. **"Sports venue"**: the place intended for the practice of sport or where such practice takes place, enclosed or delimited by walls, fences, or barriers, generally with controlled and restricted access.
5. **"Admission tickets"**: tickets, cards, invitations, and any other documents allowing entry to sports venues, regardless of their form or medium.

## 2. CONDITIONS OF ACCESS TO THE SPORTS VENUE

1. Entry to the Stadium on Event days is only permitted to Users holding a valid admission ticket, recognised by the Access Control System or by personnel assigned to door control in the event of unforeseen system failure or lack of PDA devices. Tickets are validated electronically with PDA devices, with information processed in a computerised system that updates the number of entries and identifies anomalies (counterfeit tickets, overdue membership fees, duplicate entry attempts, wrong event, etc.), or by security staff at the gates, preventing entry with invalid tickets and avoiding overcrowding.
2. Entry is prohibited to children under 3 years old in the seating stands. On Event days, children under 12 years old will only be admitted if accompanied by an adult; the Stadium management may require the purchase of a regular ticket or refuse entry to children aged 12 or under if the Event risk assessment so determines. Persons over 12 years old may enter on Event days if holding a valid admission ticket.
3. All Stadium Users must submit to a personal security search, conducted by a Sports Venue Steward (SVS) or the Police, without which entry may be denied.
4. SVS or Police may, whenever justified, require Users to undergo a breath alcohol test; if blood alcohol levels exceed the legal limit, entry will be denied. Similar checks may be carried out after entry if security staff detect signs of intoxication or drug use, which, if confirmed, will result in expulsion from the venue.
5. Entry to the Stadium will be denied by SVS or Police for any objects prohibited under legislation establishing preventive and punitive measures in cases of sports-related violence (Law No. 16/2004 of 11 May, repealed and updated by Law No. 39/2009), or items likely to endanger life or physical integrity. In addition to other objects defined by Futebol Clube de Alverca – Futebol SAD or police authorities, prohibited items include: firearms, explosives, pyrotechnics, knives, tools, syringes, cans and bottles (beverages or otherwise), umbrellas, helmets, belts, glass cups, portable radios, spray cans, balls, rigid poles, and other sharp and/or throwable objects.
6. Physical separation between supporters of different clubs is ensured in the stands. The visiting team's supporters are allocated to the North Stand, which may be changed to another sector for safety reasons. These sectors are protected with physical barriers (metal nets and other structures).
7. All violent, insulting, racist, or xenophobic behaviour, as well as the display of political or religious messages, is prohibited. Users displaying such behaviour will be ordered to leave by SVS, with police assistance if necessary. The Club and SAD also reserve the right to prohibit the entry of messages, flags, or other items bearing acronyms or symbols of unregistered associations.
8. Users who endanger the safety of the Public, Sports Agents, Officials, or Authorities, or who show signs of intoxication or drug use, or who carry prohibited items, drugs, or alcoholic beverages in the public areas inside the Stadium, may be approached and/or detained by Police.
9. On Event days, each Spectator must occupy the seat corresponding to their admission ticket and is prohibited from staying in a seat not assigned to them, accessing sectors other than those indicated on the ticket, or standing in passageways and circulation areas (vomitories, stairways, and concourses). Users are also prohibited from placing themselves in positions or locations that could

- endanger their own safety, the safety of others, or cause damage to the Stadium's facilities and equipment.
10. Users are prohibited from using loudspeakers that may interfere with the Stadium's sound system, preventing the audience from hearing public information and safety messages.
  11. Pitch invasions are strictly prohibited, except in emergencies such as riots, serious accidents in the stands, or earthquakes, where the walkways connecting the lower stands to the pitch serve as evacuation routes.
  12. In emergencies, Users must remain calm and follow all instructions provided by Security Coordination via the Stadium's sound system, SVS, Police, and Firefighters.
  13. Users consent to the collection of images and sound strictly under applicable law.
  14. The wearing or display of items related to other clubs is prohibited in the lower and upper central west stand.
  15. The introduction and use of professional photographic and filming equipment is prohibited. Only small compact devices with fixed lenses and up to 150mm zoom are allowed.
  16. At each entrance, signs indicate prohibited objects or substances, as well as posted rules for the use of the sports venue and penalties for non-compliance. Physical searches of supporters by SVS are mandatory.
  17. Only in the Presidential Tribune (specifically in the VIP boxes) is the consumption of alcoholic beverages allowed, within the limits set by law.

### 3. ADDITIONAL CONDITIONS FOR ACCESS AND STAY

1. All products sold inside the Stadium must be licensed and authorised by the Club or SAD. The sale of products not meeting this requirement is strictly prohibited. Unless otherwise authorised by the Club or SAD, Users may not bring food or drinks into the Stadium. The sale of alcoholic beverages in public interior areas, as well as narcotics and psychotropic substances, is prohibited.
2. All vendors must be clearly identified with a credential provided by the Club or SAD, which is personal and non-transferable.
3. Any advertising or brand references inside or outside the Stadium require prior approval from the Club or SAD.
4. Media outlets working during an Event may only enter with a credential issued by the SAD of Futebol Clube de Alverca, granting access to the Press Zone located in the Central Stand (access via Gate 1). Credentials define the permitted access zones for each media outlet. In addition to the Press Zone, there is a Press Room and Flash Interview Area.
5. Media publication of articles or reports about the Stadium and its activities is only authorised if for purely informational purposes, with no connection to brands or commercial references unless previously approved by the Club or SAD.
6. Users with Reduced Mobility (PRM) have individual seats with ramp access in the Central West Stand in sectors A1 and A8, and in the North Stand in sector A9 – Gates 1, 4, and 5 of the Stadium. Each PRM is entitled to one companion, and both must hold valid admission tickets.

#### 4. OPERATION OF SPECIAL ACCESS AND STAY AREAS (ZCEAPS)

1. Admission tickets are purchased exclusively online from the organiser, individually, nominally, corresponding to an identification document with a photograph, and showing the ticket holder's name.
2. The sale of tickets to persons under 16 is prohibited, except when accompanied by an adult. Minors' ages must be verified with proof of age.

#### 5. FINAL PROVISIONS

1. In addition to legal sanctions, the Club or SAD reserve the right to deny access or remove from the Stadium any Users who violate these regulations, and SVS may request police intervention for this purpose.
  2. The Club or SAD may also impose future bans on Stadium access, for variable periods, on Users who seriously, grossly, or repeatedly violate these regulations.
  3. Entry into the Stadium implies acceptance of these Stadium Regulations.
  4. The Stadium Regulations are available in physical format at the ticket office and in digital format on the SAD's website.
